

Ferrarelle S.P.A. is a 100% Italian company, which operates in the bottling and distribution of mineral waters nationally and internationally, closely linked to the excellence of the Ferrarelle brand, the natural effervescent synonymous with quality since 1893.

Fourth Italian group by volume in the mineral water sector, Ferrarelle S.p.A. today is the owner of the brands Ferrarelle, Vitasnella, Fonte Essenziale, Boario, Natía, Santagata, Roccafina, which it bottles at its two factories in Darfo Boario Terme (BS) and Riardo (CE) and the exclusive distributor for the peninsula of the Evian brand.

In 2017, the group also acquired Amedei Tuscany, an Italian company producing high-end chocolate, together with the plant in Pontedera (PI): thanks to this operation, Ferrarelle thus brings back to Italy another brand symbol of craftsmanship and of Made in Italy refinement.

The following year, the Presenzano (CE) plant was opened, the result of an investment of over 27 million, which allowed Ferrarelle S.p.A. to become the first Italian company in the food sector to have built a special plant for the recycling of PET, contributing to the creation of a "-1 impact world". In fact, the Group's corporate philosophy is based on the awareness that it is necessary to subtract more from the environment than is put into it: thanks to the Presenzano plant, the company has already removed 20,000 tons of plastic from the environment and is producing its bottles in R-PET (PET recycled directly from the company) in 1.5L and 0.5L formats.

Also in the province of Caserta, within the Riardo Springs Park (where the natural effervescence of Ferrarelle originates), Ferrarelle has planted the Masseria delle Sorgenti, a farm where organic conversion methods are followed.

In addition to protecting the environment, the Group undertakes to guarantee a balanced distribution of economic value among the various stakeholders and to encourage the growth of the intellectual, social and economic assets of each place and community in which it carries out its business, through institutional partnerships.

With a statutory turnover of 204 million euros (2020), the company now has about 500 employees spread over 5 strategic sites: Milan, headquarters of the sales and marketing management; Riardo (Caserta), administrative and operational center where the Sorgenti Park, sponsored by the Fondo Ambiente Italiano, houses the sources of Ferrarelle, Santagata, Natía and Roccafina; Darfo Boario Terme (Brescia), cradle of the Boario, Vitasnella and Fonte Essenziale springs; Pontedera (Pisa), Amedei Tuscany factory; Preszano (Caserta), headquarters of the R-PET, recycled PET production plant.

The company is also expanding abroad and with Ferrarelle and Natía it is in distribution in the USA, United Kingdom, France, Spain, Germany, Denmark, Russia, Israel, Japan, Hong Kong, Taiwan.
